SERVICES AGREEMENT

This agreement is made on

26th January 2023

-BETWEEN-

The Principal of Bikali College, Dr Monoj Gogoi, Dhupdhara & District – Goalpara, Pin – 783123, Assam.

,herein after to as the "Buyer" of the 1st party.

-AND-

Shri Dhrubajyoti Das, S/o Narayan Ch Das, Director of "DJ Enterprice". Here in after referred to as " SERVICE PROVIDER" of the 2nd party.

Both of them are collectively referred to as the "Parties".

The objective of this agreement is to provide infrastructural and service facilities for conducting skill Training to candidates under various Skill development project to provide Entrepreneurship and Skill Development Training Programs(E&SDPs) for the skill sets, which are/ will be in demand by the market leading to self/wage employment with emphasis on wage payments, to promote Skill India Mission.

Now both the parties have mutually agreed with following terms & Conditions

1) Duration/Term of Agreement

i) This MOU is valid from 26th January 2023to 1st DECEMBER 2026.

ii) The same MOU can be renewed for another term subject to mutually agreed terms & conditions. Upon successful completion of the tenure both the parties can also get engaged in different schemes which would be available during that time.

2) General Terms & Conditions

- a) That this appointment as Buyer has its own center at (**Bikali** College, **Dhupdhara** & District **Goalpara**, **Pin 783123**, Assam) under several job roles for skill purposes of second party is for the purpose of imparting to youth as per the proposed programs under various skill development scheme which is an initiative of Ministry of skill and Entrepreneurship, Government of India and paid courses like ADCA and DCA.
- b) That the First Party shall not have any right to transfer its rights to any other person or body in any manner what so ever except as said above. However, the First party shall have rights associated with its current courses and expansion relating to its current courses and those unrelated with this agreement.
- c) That Second Party would be entitled to enroll number of candidates as per approved number for each (job roles) and allocated to center of First Party for the respective training. Simultaneously note that Accreditation, Affiliation or service agreement to a training center does not make auto eligible for targets under any scheme like PMKVY,ASDM, Khadi Village India etc.
- d) That this Service Agreement is made clear understanding that Accreditation, affiliation of a training center under Service Provider " Shri Dhrubajyoti Das" is no way compels " Service provider" to allocate target to the Service Partner.

- e) That the Second Party shall provide all technical knowledge of the scheme along with Standard Operative Procedures & report formats to be submitted by First Party to the Second Party as per Project guidelines.
- f) That the sole responsibility of passing the examination/ assessment is of the candidates enrolled under the program. The Second party or aggregator shall no way be held liable if the candidates fails or pass assessment conducted by the respective Sector Skill Council (SSC).
- g) That candidates is required to submit his/her PAN/VOTER/AADHAAR CARD No. & the Bank Account No. Within one week of start of the program or subject to scheme as per requirement.
- h) The Biometric attendance system must be available as per the guidelines at the training center as per the guidelines of the Project.
- i) The Buyer shall provide us with the room required like Reception, Placement & Entrepreneurship cell, Library, Pantry, room for lab and room for classes .
- j) First party would not attach their TC to any other TP or any Society or NGO before this MOU is over.
- k) The Second party will pay the Trainer TOT fees .
- The Second party will pay all the fees of creating the Training Center and job role fees and miscellaneous.
- m) An amount of Rs 1000 per candidate will be paid to college, where Rs 700 is towards the payment of staff and trainer salary and remaining Rs 300 will be towards rent, electricity etc. The amount of Rs 1000 will be paid 30% after successful completion of Classes as 1st installment and remaining 70% after getting from the ASDM as 2nd installment or said office.

5)<u>Confidentiality</u>: Both Parties agree to respect confidentiality of technical knowledge provided to each other during the term of this MOU and not to share with any third party in any form or way.

6) Termination:

That both parties can terminate this MOU after 2 year at any point of time if mutually agreed for the same but the obligation of this MoU will remain in force till training of already enrolled candidates is completed.

- 1. Making professional psychotherapy and counselling services accessible at grass-root level
- 2. Aiding early identification and psychotherapy for emotional and behavioural disturbances
- Strengthening peer, teacher and family level communications and support for emotional and behavioural distress
- Laying the foundation to destigmatize concepts of mental illness, psychotherapy and helpseeking for emotional problems
- 5. Promoting positive mental health and foster an environment of acceptance and support.

The project is being launched as part of Ashadeep's Silver Jubilee initiatives. It shall be executed with infrastructure support from Bikali College.

A. Roles & Responsibilities

Ashadeep

- Shall provide professional psychotherapy and counselling services to students and staff members of Bikali College, Dhupdhara, and in cases where deemed necessary, to their family members as well.
- Whenever required college counsellor shall be trained by resource personnel from Ashadeep for identification of mental health related behavioural and emotional difficulties, and delivering primary psychotherapeutic services.
- Mental health professional shall deliver their service once every month to a maximum of 5 individuals in one visit.

- 1. Shall provide adequate, clean, furnished and well lit physical space for the services to be delivered such that privacy of sessions is maintained.
- 2. College counsellor shall primarily be responsible for identifying individuals requiring professional psychotherapy services.
- 3. To meet any infrastructure and/or resource requirements placed by the mental health professional.

B. Time Frame & Finances

- 1. No monetary charges shall be made for the psychotherapy and counselling services.
- The said services shall initially be provided for 1 year of duration and subsequently extended for a period of up to 3 years (inclusive of the first year) provided the College meets the travel and refreshment expenses of the service providers.

This Memorandum of Understanding is the complete agreement between ASHADEEP, Guwahati. Assam and BIKALI COLLEGE, Dhupdhara, Goalpara and may be amended only by written agreement signed by each of the parties involved.

- 2. And whereas for implementing its NFSE activity, the CSU makes collaborations with the Universities, Colleges, Institutions etc. desirous of promoting Sanskrit learning to
- its students/staff and general public within its reach, through NFSE Centre along with other similar academic activities at their organisation.

 - b. Prescribed monthly remuneration to be paid by CSU. (In addition to his duties in the allotted Centre, he may be required to teach the learners at any other nearby Centre/Centres if required).
 - c. Reading material for the learners
 - d. Prescribed guidelines for NFSE
 - e. Conducting examination at the end of academic session and awarding certificate/diploma to the successful candidates.
- 5. And whereas, the CSU will undertake Sanskrit education for Certificate Course in Sanskrit Language and Diploma in Sanskrit language of the duration of one year each for the learners in NFSE Centre, Learners enrolled in the Centre will be required to deposit prescribed Registration fee to the CSU.
- 6. And whereas Bikali College will provide the facilities and extend support as under
 - a. Suitable arrangements for functioning of NFSE Centre, including seating arrangements, infrastructure, electricity etc.
 - b. Nominating a faculty member as authorised officer to coordinate functioning of the Centre. He will be required to ensure that the courses are conducted as per the provisions prescribed in the guidelines for NFSE.
 - c. Publicising the Sanskrit learning courses of CSU in non formal mode and also making arrangement of the same at its Centre.
- And whereas in any matter concerning the NFSE Centre or any issue arising in conducting the courses, the same will be resolved jointly by the authorised officers of CSU and Bikali College.

WHEREAS Assam down town University was established through the Assam down town University Act, 2010 by down town Charity Trust established a multi-disciplinary University in the year 2010. Assam down town University is located at Panikhaiti, Kamrup (M) in the Assam state capital region, 12 km away from Dispur. Assam down town University (AdtU) is approved by UGC (University Grants Commission), the Government of Assam, AICTE, and AIU (Which expression unless excluded by or repugnant to the subject shall mean and include its successor-in-office and permitted assignees) of the "FIRST PARTY".

Bikali College is one of the premier institutions of higher education in the state of Assam. The college is currently affiliated to Gauhati University and is presently offering bachelor degree courses in Arts, Science and Commerce along with post graduate Master degree courses in Assamese and Geography. Bikali College having its official at Dhupdhara, Dighali Pachim, Assam- 783123, hereinafter called "SECOND PARTY".

 Scope of MoU: The broad objective of this MoU is to have a common platform for Research, Exchange program for Faculty and Students, Internship and Training program for students, Joint consultancy and Project implementation, and any other activities as agreed upon by both parties.

2. Modalities of MoU:

- a) To take up initiatives for the exchange of information relating to activities in teaching and research of mutual interest.
- b) Post-graduate and Doctoral research projects/work to be carried out in the AdtU campus and the colleges (wherever adequate laboratory facilities are available) as per the requirements and approved plan of work.
- c) AdtU would recognize college teachers and research scholars working in different colleges for pursuing doctoral degrees as per relevant Ph.D. rules and regulations of AdtU.
- d) AdtU will consider certain laboratories of the college based on the required facilities for conducting doctoral research and recognize faculty members as research supervisors subject to fulfilling the Ph. D. Supervisorship as per AdtU norm.
- e) Both parties will provide the field, laboratory and other facilities for undergraduate, Post-Graduate, and Ph.D. scholars to carry out mutually agreed research programs.
- f) Research findings as a result of this collaborative work of both parties could be jointly published in the public interest.
- g) AdtU will offer free-ship/scholarships to poor meritorious students for higher education on recommendation from the college authority and also as per admission guidelines of AdtU.
- 3. Faculty exchange program: For the smooth running of the academic program of different natures, the faculty/student exchange program shall be taken up through mutual experience in teaching and research during the semester. Honorarium, transportation, and accommodation/hospitality as per respective institution norms.

- 4. Organization of Seminars/symposia/workshops/training programs: To organize short-term training programs/internships on certain topics of mutual interest; to organize seminars/conferences/workshops of national and regional interest. These will bring academic exposure for faculty members and students of both parties.
- 5. Collaboration on outreach event: To have a joint collaborative program to accelerate entrepreneurship, and innovation and to conduct outreach activities for the benefit of the society.

- 6. Submission of collaborative projects: Based on their interest and expertise, AdtU faculty members will collaborate with eligible faculty members of the college in a specific domain of research and submit project proposals to funding agencies and vice-versa. In all such cases, faculty members of both institutes follow the guidelines of funding agencies and the rules of the respective parent institute.
- 7. Study tour program: To jointly organize a study tour program in location specific areas and interests.
- 8. Co-Curricular activities (Sports, culture, debate, quiz, etc.): To jointly conduct some Inter-University/college events, nature camps, field trips, and sports cultural programmes having common interests.

9. Role and Responsibilities:

- a) Both parties will nominate/designate one nodal officer (not below the rank of Assistant Professor) from respective institutions for smooth conduct of the program and facilitate implementation of any/or all agreements arising out of this MoU.
- b) To take up collaborative research work based on location specific problems on project mode on mutual agreement hereafter with appropriate funding by respective parties including externally funded projects.
- c) Neither party shall be held responsible for the non-fulfillment of their respective obligations under this agreement due to the exigency beyond the control of both parties.
- d) There will be no financial obligations on both parties under this MoU.

10. Duration of MoU, Amendment, and Termination:



9. Commercials



PRINCIPAL **BIKALI COLLEGE** DHUPDHARA

1. SCOPE OF AGREEMENT / MoU

The Regional Sericulture Research Station, Central Silk Board, Boko being nodal agency for sericulture development in the region and Bikali College, Dhupdhara being State College working towards research, teaching and extension needs of Kamrup and Goalpara districts, both parties have agreed for collaboration for:

- a) To provide quality education and training in the areas of sericulture and allied fields.
- b) To conduct sericulture research in areas of mutual benefits

4. FORCE MAJEURE

a.
